Personal precautions, protective equipment and emergency procedures

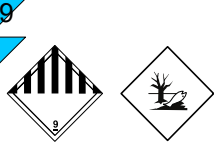
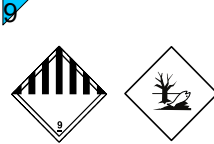
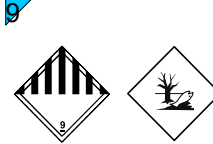
Section 13. Disposal considerations
