Hazards from the substance or mixture : In a fire or if heated, a pressure increase will occur and the container may burst.

5.3 Advice for firefighters

Special protective actions for fire-fighters : Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training.

Special protective equipment for fire-fighters : Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode. 6.2 Environmental precautions

Small spill : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble.
